An Act to provide for the validation of certain actions of the Managing Body referred to in section 4 of the Indian Red Cross Society (Bengal Branch) Act, 1920.

WHEREAS it is expedient to provide For [he validation of ccrain actions of the Managing Body referred to in section 4 of the Indian Red Cross Society (Bengal Branch) Act, 1920;

It is hereby enacted in the Fifteenth Year af the Republic ofTndia, by ihe Legislature of West Bengal

1. U) This Act may he called (he Indian Red Cross Society (Bengal Branch) , as follows:ô (Validation) Act, 1964.

(2) II shall be deemed lo have come into force on the 19th October,

2. In this Act, unless there is anything repugnant in the subject or Definiitions, context,ô

(1) "the Amending Act" means the Indian Red Cross Society (Bengal Branch) (Amendment) Act, 1963;

(2) "the Principal Act" means the Indian Red Cross Society (Bengal Branch) Act, 1920 as it existed immediately before the commencement of the Amending Act;

(3) "new Managing Body" means a Managing Body constituted in accordance with the provisions of the Principal Act as amended by the Amending Act;

(4) "old Managing Body" means the Managing Body constituted and functioning under the Principal Act.

3. Notwithstanding anything lo the contrary contained in the Principal Act as amended by ihe Amending Act,ô

- (i) the old Managing Body shall, after the commencement of the Amending Act and until a new Managing Body is constituted, continue to function under ihe Act as amended by the Amending Act, and (ii) anything done or any action taken commencement of the Amending Act by, or on behalf of, or in respect of, ihe old Managing Body or any member thereof, shall be deemed lo be and lo have always been validly done or taken as if such Managing Body were a duly constituted new Managing Body.
